6. Status Update on the Application for Accidental Disability Benefits for Matthew Feddeler

Ms. Strisko said that at the October 6, 2022 meeting, the Board approved moving Matthew Feddeler forward to an Independent Medical Examination (IME). There are two parts to the examination, and they took place on December 8, 2022 and January 5, 2023. Staff has received the reports, and Mr. Feddeler's attorney has asked that this item be held until the March meeting. Boardmember Moreno asked if there was any additional information on the application. Ms. Sorensen said that she has been in contact with Mr. Feddeler's counsel, who is out of town this week, regarding options for moving forward. Mr. Norris has not been able to discuss options with the applicant, which is why it is deferred to March.

7. PSPRS Updates

Ms. Strisko said that PSPRS sent out a Frequently Asked Questions for Public Safety Employers & Members on the Extended DROP which allows for DROP to be extended from 5 to 7 years. The city is allowing its employees to extend their time, should they qualify and choose to do so. Additional notifications include the Employer Valuations Available Online and the PSPRS FY 2023 First Quarter Newsletter. Lastly, the Employer-Local Board Conference Registration Open and will be held March 1. HR staff will be attending, and Board members are encouraged to attend.
