


Addressing Recommendations

- Tempe Family Advocacy Center
 - Opened to the public in February 2023
 - Victims do not have to report to PD to receive services
 - All services are confidential
 - Advocacy Support- cases will not be closed
 - If ready to report to PD, all victims will be supported by an advocate through the entire criminal justice process
 - DV Court –Order of Protection/Injunction Against Harassment included
 - Trauma Healing (non traditional counseling) services are available on site



Why it all works...

- Part of the Community Health and Human Services Department-Not part of the police department or courts
- Direct connection to Crisis Response Teams, Counseling, Veteran's Services, Long-Term Case Management, Youth Specialists, and Trauma Trainer
- Direct connection to other working groups in the Community Health and Human Services Department
- CARE 7, Tempe Police Department, and Tempe Fire Medical Rescue- Partners in providing services to the public
- All practices are based on trauma informed standard
