Agenda Item 4 - Updates: Arts & Culture Division

- Arts Grants, Maja Aurora
 - o Three grant categories, Wave Maker, Vibrant City, Arts in Schools
 - Vibrant City Grant, Cycle Two deadline Nov 15
 - Arts in Schools serves fine arts programs in schools in the Kyrene School District, Tempe Elementary School District, and Tempe Union High School District. This year the focus is on supporting clinicians or guest artists in classrooms.
 - Fine Arts teachers have two grant options:
 - Grant request for specialty supplies
 - Grant request for artist or clinician for in class residency
 - The grant amount has doubled in 2023
 - 42 grants have been awarded; 25 teachers chose to work with guest artists or clinicians
 - Tempe will pay artists directly to speed up payments and reduce paperwork for schools

- Tempe Playlist, Maja Aurora
 - 2023 is the third cycle of Tempe Playlist (started in 2017)
 - Supporting the professions of local musicians and bands actively performing in the valley
 - 44 of 115 band applications selected for Tempe Playlists
 - Spotify Tempe Playlist: https://open.spotify.com/playlist/5xzLYd2sr4T1flCYIGphqm
 - Photo shoot supplied by Tempe supplying 10 high resolution images to each band/artist
 - o Tempe events are pulling musicians directly from this pre-qualified list
 - o Tempe Playlist Booklet is online: Tempe.gov/tempeplaylist
 - Commission questions:
 - How does the team determine to which businesses to distribute the book?
 - Team is researching businesses actively booking live music
 - Can the list get pushed out to businesses procuring a live music permit?
 - Are you getting feedback from musicians about successes?

 - o A FY23 recap was presented.
- Signature Arts Event, Brendan Ross
 - o Proof of concept year in 2024 to build a full program launch in 2025
 - Brainstorm and trial programs, ideas, and marketing
 - Build staff
 - Scoping
 - Researching pop up events and broadening events as a once-per-year offer
 - Building partnerships with local organizations and stakeholders like Gammage,
 Downtown Tempe Authority, ASU, and others
 - Spiegeltent planning for delivery in 2025
 - O'odham/Piipaash activations to be explored when the tribes are ready for those conversations
 - Advisory group to begin meeting in October (to include TACC Chair)
 - o Hayden's Ferry Festival to be held earlier in March to give the event its own space
 - TACC involvement:
 - Thank you for all the good ideas and enthusiasm
 - Please bring ideas or network opportunities to staff for consideration
 - More opportunities will be coming soon
 - Commission comments:
 - Are there walking, travelling, or pop up arts experiences that can fill a gap in the Equity Study?

- Live music is very important to the history of arts in Tempe, could it be included in the list of programs under scoping?
- Will walking/travelling experiences have a bicycle element?
- Walking/cycling access: Ensure accessibility is equitable across Tempe
 - Maureen to run things by the Disability Commission for ideas
- With what native organizations is Tempe working?
 - A collection of O'Odham and Piipash creatives, architects, designers under the name Hekiu
