### 4. Local Board Policies for Accidental Disability Benefit Applications

Board Legal Counsel Lesli Sorensen said a document tentatively titled *Guidelines for Disability Applicants* based on the discussion with Dr. Kirkorsky was included in the board packet. It is intended to be an informational handout for applicants. It is up to the Boards to determine if any corrections or edits are needed as well as how to proceed. The item was opened for discussion.

Boardmember Ferraro asked for additional time to review prior to the Board making a recommendation. Mr. Ferraro asked if this would be provided as a part of the packet. Ms. Sorensen said that there isn't a requirement for applicants to obtain the packet from the city. The document is organized into sections Board Process, General Information on mental or physical disability applications, cancers, and types of disabilities under PSPRS. Mr. Ferraro asked if the Boards should approve the document and then make any necessary changes. Ms. Sorensen recommends making any changes prior to Board approval.
