March 19, 2024 Hearing Officer Minutes

Vanessa MacDonald, Hearing Officer, stated that the March 19, 2024 Hearing Officer Minutes had been reviewed and were approved.

2. Agenda Item No. 2

Request approval to abate public nuisance items at the Roosevelt E11even LLC Property located at 606 South Roosevelt Street. The applicant is the City of Tempe (CM231961).

- Michelle Van Etten, Code Inspector, gave the following overview of this case:
 - o Inspector Van Etten requested a 180-day open abatement for 606 South Roosevelt Street.
 - The case was initiated on 11/30/23 for graffiti.
 - o After a reinspection of the property, tall grass and weeds were observed.
 - No contact has been made from the property owner.
 - Additional complaints have been received by the Community Enhancement Division.
 - The inspector then presented photos taken earlier in the day showcasing the violations on site.
- Shawn Daffara stated no contact has been made by the property owner or any other member of the public to speak on behalf of this case.
- Hearing Officer MacDonald approved the 180-day open abatement request found in CM231961.

3. Agenda Item No. 3

Request approval to abate public nuisance items at the Kenton Brown Property located at 1208 West Malibu Drive. The applicant is the City of Tempe (CE231393).

- Hector Heredia, Code Inspector, gave the following overview of this case:
 - o Inspector Van Etten requested a 180-day open abatement for 1208 West Malibu Drive.
 - o The case was initiated on 3/8/23 for an inoperable/unregistered vehicle.
 - o Additional complaints have been submitted to the Community Enhancement Division.
 - o A citation was also issued. The property owner did not pay the fee and it was sent to collections.
 - o The inspector then presented photos taken earlier in the day showcasing the violations on site.
- Shawn Daffara stated no contact has been made by the property owner or any other member of the public to speak on behalf of this case.
- Hearing Officer MacDonald approved the 180-day open abatement request found in CE231393.
