- Pristine state as possible.
- Facilities or improvements necessary or appropriate to support City activities.
- Limited traditional public park facilities or improvements.
- Provide cultural, educational, and recreational opportunities.
- Provide equestrian, pedestrian, and vehicular access.
- Scope of Work
 - Identify and assess elements present in preserves (natural, cultural, rec, structural).
 - Management goals and success metrics
 - Best management practices
 - Action items; near, medium, long-term actions
 - Final MP document
- Preserve Management Plan Draft Review
 - Draft Plan
 - Workshop/outreach info to be added from upcoming sessions.
 - Tribal consultation has yet to be incorporated.
 - Word format; formatting issues to be addressed in InDesign.
 - Pictures and maps to be added.
 - Review
 - Recommendations
 - Objective, implementation, and success criteria
 - Introduction & existing conditions
