**Agenda Item 5 – Chair Remarks**

### **Agenda Item 6 – Victim Awareness Campaign – Commission Jeanette Costa**

The commission looked and reviewed various signages of Victim Awareness. Members spoke on what they hoped the signage would say and remarked on other campaigns such as sex trafficking during major sporting events.

The commission also spoke on the logistics of running such a campaign, its cost, where this signage will be, and who will lead it. It is the initial hope of this commission that CARE 7 could be the leading department at the given moment. Commissioner Costa and Stinchfield will provide more information on this topic and present it next month.

### **Agenda Item 7 – Review Tempe Police Department’s Quarterly Report- Commission Josie Montenegro**

The report showed that the final quarter of 2021 saw a decrease in reported cases interested in this commission. This included assault DV, aggravated assault DV, and sexual assault, among other crimes. Still, this lower number may not reflect the status of crime in Tempe, as there could be a disconnection between it and actual crimes. There could be several factors affecting the reported cases.

The commission talked about this potential disconnection. Tempe PD is always trying to build a good rapport with our community. They promote victims to feel safe and report whatever may have happened. This includes promoting victims to come forward with past assaults.

### **Agenda Item 8 – Review CARE 7 Quarterly Report- Commission Member Anastasia Stinchfield**

Past victims are returning at a greater rate; they seek assistance in numerous fields. The number of victims here may not be a one-to-one comparison to Tempe PD’s report. Some victims acknowledge their assault to CARE 7 but may be fearful of reporting it to Tempe PD. CARE 7 and Tempe PD have a close working relationship and acknowledge the benefits of each other’s department

CARE 7’s 4<sup>th</sup> quarter report ended on September 31, while Tempe PD’s 4<sup>th</sup> quarter report ended on December 31.

Commissioner Stinchfield is open to gathering additional information if the commission requests it. It would be helpful to know what particular services are being requested of CARE 7.

### **Agenda Item 10 – Sexual Assault Awareness and Prevention Discussion**

Commission members and Paul Bentley moved through the memorandum, editing specific sentences to reflect better the voice that the commission would like to have. Details of specific sentences were discussed at length; they clarified elements so that commission members would fully understand the meaning of the memorandum. Moreover, information from other departments will be pulled, so the memorandum provides updated information.

### **Agenda Item 11 –Family Advocacy Center Update and Discussion**

The task force has had ongoing discussions with a property manager and owner. The Family Advocacy Center Task Force and property manager/owner have agreed on a space plan. The property owner/manager will provide a cost estimate for tenant improvements (TI) in the near future. Lease agreement negotiations will begin once the TI estimates have been provided. It is the hope of the task force that the Center be open for services before the end of the fiscal year.

### **Agenda Item 12 – Commission Member Updates**

Tempe Leadership is sponsoring a charity golf tournament in which the proceeds will go to the Family Advocacy Center.

The commission is currently looking for an ASU faculty member to fill the current vacant commissioner position; commission members were asked identify/recruit qualified candidates.
