Agenda Item 5 - Discussion: Maker District & Smith Innovation Hub Strategy

- B. Ross gave an update:
 - A new draft of guidelines has circulated internally; Brendan is keeping an eye that all entities involved stay aligned with the role of the arts in this initiative
 - O Will come back with clear information about launch and rollout
 - O Comment:
 - Ginny: Some neighbors are concerned about the implementation of the guidelines as they pertain to the commitment of ensuring art integration with both locations; concern about the addition of high rises within the developments;
 - Justin: Thanked the staff for being ahead of the curve and averting the projects from changing direction away from arts and away from what was originally communicated as a priority in the strategy
 - o TACC can have influence in certain strategies

Agenda Item 6 - Discussion: Arts & Culture Outbound Strategy

- B. Ross gave an update:
 - A request has been submitted to council for new marketing budget to include new staff positions and converting the marketing team to service the Arts & Culture Division as a whole, not just TCA
 - There have been discussions with City communications staff about improvements to the Arts & Culture website in conjunction with the TCA website
 - Investigating an inner process around new ticketing software and help improve digital integration
 - o Creating new strategic invitation opportunities for Arts & Culture Commissioners for events

Agenda Item 7 - Discussion: Signature Event Strategy

- B. Ross gave an update:
 - Have met with ASU, DTA, and other local stakeholders on planning the event as a partnership
 - A request has been submitted to council for baseline program budget and includes one new staff person
 - Currently collecting national and international references for programming and business models

Comment

- What can TACC do to make budget asks a reality?
 - Remind city stake holders that this is an item out of the A+C plan of 2015 as unfinished business
 - Share enthusiasm for this idea around the city
- When talking about this idea, remind others that Tempe has a strong history of arts and culture and that the community voted twice to fund Arts & Culture via an allocation of sales tax
- Please send out a short questionnaire on what the community would like to see in a signature event. Seek early input for planning.

 - Jacqueline Bernatt: There weren't many nominees; we need ways to tell people about the awards; uncover small, local arts events that are deserving of attention;
