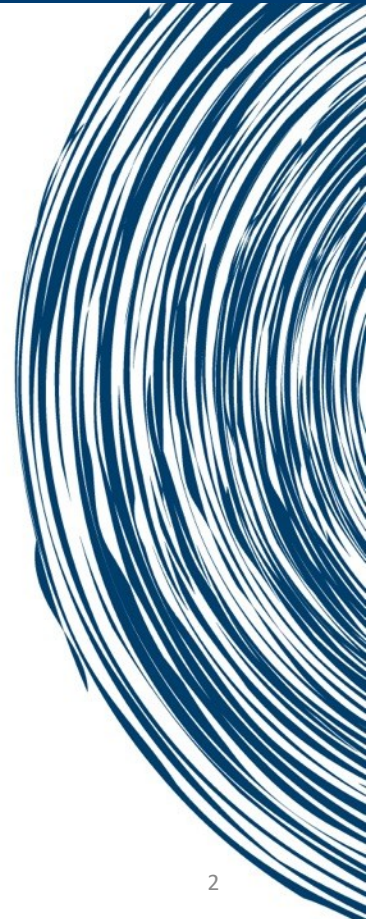

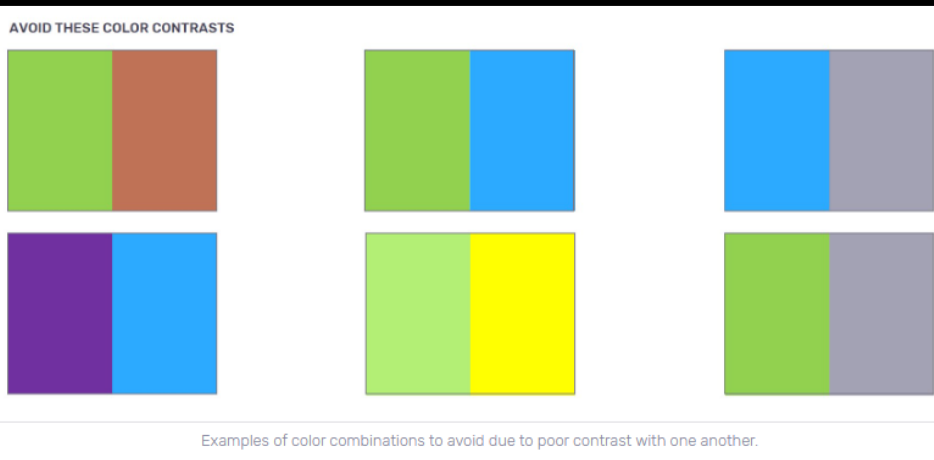

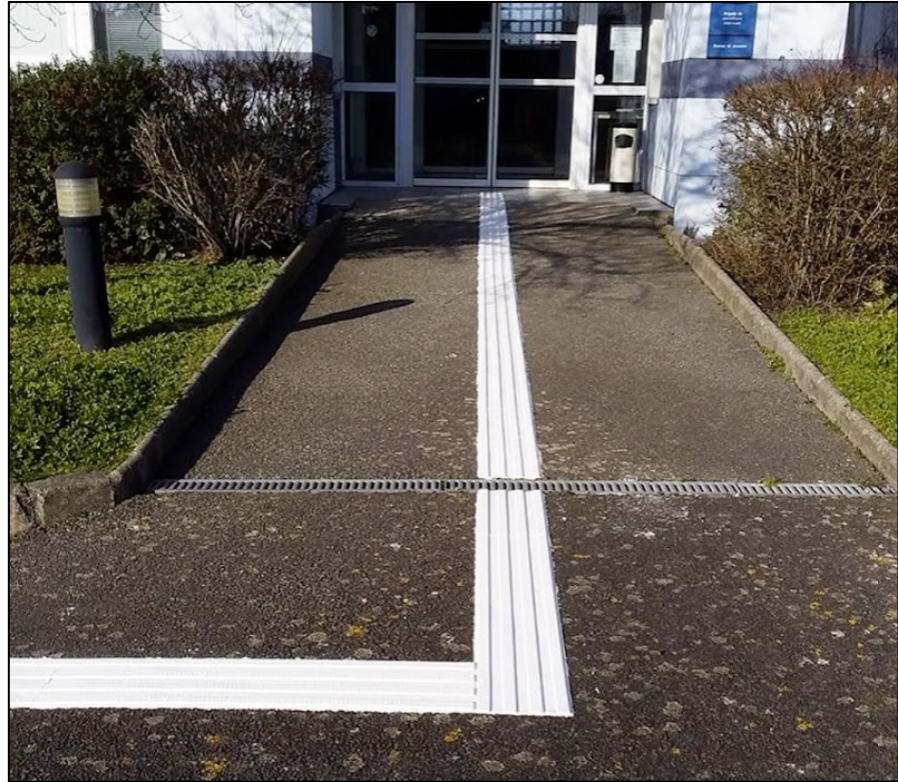

We will include at least one member from each board and commission and partner organizations. We may keep the other member's name as an alternate, and when needed, we may invite the second member to TAG meetings to ensure representation, diversity, and inclusiveness.

TAG meetings will last 1 to 1.5 hours. It will meet bi-weekly in the beginning months starting in August 2022 and until September 2023. However, TAG will remain active until December 2023.

We will have an orientation meeting in June 2022 for the TAG members.

General Plan 2050, Technical Advisory Group (TAG)

The City of Tempe has begun to work on the development of Tempe Tomorrow: General Plan 2050 (GP 2050). GP 2050 will be an overarching policy document for the City of Tempe incorporating community's vision and aspirations for managing growth in the long term. The time horizon for GP 2050 will be 2024-2050.

Purpose, Roles, and Responsibilities of the Technical Advisory Group

The Technical Advisory Group (TAG) is a group of representatives from relevant boards and commissions of City of Tempe, non-profit partner organizations, and city staff from various departments that will provide technical guidance, support, and assistance to the City in the preparation of the Tempe Tomorrow – GP 2050. The TAG offers an opportunity for the members to be a vital part of planning Tempe's future.

The responsibilities for TAG members will include the following.

1. Represent the respective board, commission, or partner organization and provide input into the process of developing Tempe Tomorrow - GP 2050.
2. Attend regular meetings to discuss technical elements of the general plan and to offer input. Anticipated time period is August 2022 – December 2023.
3. Bring any important updates to the respective board, commission, and partner organization at their regular meetings, and seek any feedback or recommendations from them.
4. Be a liaison of the Tempe Tomorrow staff team with their respective board, commission, and partner organization for discussion, feedback, and input.
5. When desired, attend any monthly meetings of the Council-appointed Community Working Group (CWG) for the GP 2050. The CWG represents Tempe's larger resident and business community to guide the development the GP 2050.
6. Champion the GP 2050 in their boards, commissions, organization, and community when it gets scheduled to go to the Council hearing in 2023, and for citizen vote in 2024.

PURPOSE:

The purpose of this memo is to request that the Commission select a recipient for the city's annual Bike Hero Award.

He also provides outstanding visibility for biking in Tempe – through his photographs, videos, and creative participation, he makes biking look cool and inspires others to join in.

When thinking about Hoss as a bike hero, there are several things that stand out to me. First is his commitment to cycling. For 20+ years, Hoss has led a group road bike ride which he calls "The Friday Ride" every Friday morning, starting and ending in Tempe. Anyone is welcome to join, but the core group is primarily avid distance road bikers. They begin their ride by crossing the Mill Avenue bridge, follow a route north to Camelback/Paradise Valley, and return to Tempe over the Mill Avenue bridge. He has a website and Instagram page dedicated to The Friday Ride where he touts the Friday PV Hills ride as "Every Fricken Friday Morning." There are other rides he hosts on occasion, but the Friday Ride is the longest running scheduled ride. Hoss also takes amazing videos and photographs during these rides and posts them on Instagram, which really makes cycling – and cycling in Tempe, specifically – look very cool. He captures the cyclists passing through Tempe's downtown during beautiful sunrises, with the festive lights on the Mill Avenue Bridge, and occasionally dressed up in silly outfits and costumes. Last October, he dressed up as a Killer Bunny for the Friday Ride! The photos from that really captures Hoss' whimsical creativity and appeal to make cycling fun for everyone, whether you join the ride or simple enjoy the photos online.

He also runs The Friday Ride group on Facebook.

The second thing that really captures Hoss' love of cycling is his collection of bicycles. For work, Hoss is a local silversmith who creates custom jewelry from his Tempe home-based studio. He keeps his collection of bikes in his studio, so anyone who comes to his studio to admire his jewelry also marvels at his bike collection. He loves to talk about his bikes and tell stories. He owns some historic bikes, including a vintage bicycle built-for-two, which he brought on a casual group ride with us last fall.

And finally, Hoss is an advocate for bike safety and bike-friendly roads by increasing public awareness through visual media and storytelling. Road biking comes with many hazards and Hoss is not afraid to document that as well. When a fellow cyclist has an accident due to road hazards, he captures the images and shares their story. By doing this, he increases public awareness of bike hazards in our community, which stretches of road should be avoided by bikers, and how the public can help make biking safer. As an example, he captured photos and told the story of a young rider who crashed when he caught his front wheel in the rail grooves in the pavement for the new streetcar on Mill Avenue. It wasn't an angry post, but rather a cautionary tale. It was a strong visual reminder of what can happen

when a rider is caught off guard by a road hazard and a reminder to city planners that bike safety needs to be incorporated into planning for multimodal spaces.

As a final note, Hoss also participates in local benefit rides and Tempe biking events.

Through his longstanding commitment and dedication to the show-and-tell of biking in Tempe, I believe Hoss deserves to be the 2022 Tempe Bike Hero.

I am nominating my husband Dr. Clinton Lepetich for the Bike Hero Award. He is definitely a bike hero to our family! He grew up riding bikes as a hobby and then used that hobby as an outlet to relieve stress and anxiety. He has taken that lifelong love for biking to inspire his children and teach them that they can accomplish the goals they set.

Dr. Lepetich grew up on a 2 acre urban farm right in the heart of south Tempe. The son of an east valley OBGYN and stay at home mom, He is a faithful member of The Church of Jesus Christ of Latter Day Saints and a graduate of Waggoner Elementary, Kyrene Middle School, Corona Del Sol High School and Arizona State University. When he was younger he said his bike gave him freedom. He spent a lot of time riding through south Tempe neighborhoods and participating in bike races with his father and brother. It became something the three of them bonded over. It continued to be a hobby he enjoyed celebrating with his father until his passing in 2019.

After graduating from Arizona State University Dr. Lepetich started dental school at ATSU and instantly knew he wanted to pursue pediatrics. We were married after his first year and started our family. The long hours and pressure of school and family were a new weight for him to carry. He instantly went to his bike to relieve that stress and would frequently take it out to the trails of South Mountain or the East Valley roads. We made an agreement that he needed to put this hobby high on his list of priorities as an outlet for his personal well being and a way to constantly push himself. That or it was just constant competition with his best friend Trent, but most likely both. Over the next few years he competed in

local road and mountain races. He pushed himself to new lengths and repeatedly shocked me over and over again. I remember being his support team for the 24 Hours in the Old Pueblo race. It was nonstop riding for over 24 hours. It was brutal and exhausting and he did it with the best attitude and didn't quit.

As I reflect on the last 12 years of our marriage through the ups and downs and 5 kids later those bicycles are ever present in my memory. I remember living in a tiny house that I don't think was even 1,000 sqft with our first two children, three dogs and a potbellied pig. We barely had room for ourselves but there was a road and mountain bike in our laundry room. I had to use some serious acrobatic skills to reach the washer and dryer. Now that our family has grown and we are setting down roots in Tempe our collection of bikes has grown, exponentially. It is something we do as a family. A way to push ourselves and support one another. We can be seen biking all over Tempe as a family. Him riding his Yuba cargo bike carrying 3 toddlers, a dog and bunch of snacks and water and the rest of us following in a pack. I really have no idea how he does that. But I don't think he loves anything more. He recently motivated us to set a goal of reaching 100 miles in a day. We worked at it slowly 20 miles one weekend, then 40 miles, 60 miles and last month we completed 100 miles in a day. This with 5 kids in tow. It was something I never imagined we would be able to do but we did it. Can you imagine being an 8 and 10 year old kid and accomplishing that so young? I cant wait to see what they can accomplish in the future with such an amazing role model. He even blew us all away last year when he finished an ultra marathon. He ran 100 miles over two days. It was the craziest thing I've ever seen him do and I hope he never does again! His car broke down a couple of years ago and he decided not to replace it. If the family car isn't available he bikes or runs. Its been three years of this and I think its here to stay!

Last year someone asked me what the best day of my life was. I thought for a moment and instantly thought of the day he got me out on the bike. I would always say no you just take the kids. But he finally convinced me to go. He put me, three kids and our dog in his Yuba and off we went. I will always remember looking up from the cargo bike, seeing everyone's calm smiling faces and feeling the cool wind blowing through my hair. We rode to Tempe Beach Park together and back. Stopping on the ASU campus with our children as we frequently do. I watched them walk around and play and imagined them as grown and in college. I will always be my very favorite day and marked it in my calendar as "live your life weekend" as a reminder to get out and see the amazing community we are so lucky to call home. I hope that when my children grown up and walk the grounds of ASU or ride their bikes through the Easy Valley they remember these very special times and how much joy it has brought to their lives and the importance of family and community.

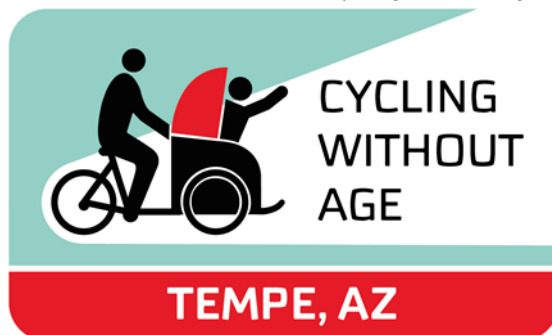

Heroes aren't always people who demonstrate valor in the face of adversity. SUBJECT: Hayden Flour Mill Redevelopment

In September the City issued a Request for Proposals (RFP) for the lease and development of approximately 5 acres of City-owned land comprising the Hayden Flour Mill located at the southeast corner of Mill Avenue and Rio Salado Parkway. On February 10 of this year, Tempe City Council awarded the RFP to the Venue Projects and Sunbelt Holdings development team, whose proposal demonstrated successful completion of high-density mixed-use developments and experience in developing multi-phase, multi-use historic preservation projects.

The land is at the base of the Hayden Butte Preserve and currently has one building, one structure, and multiple objects on the property, specifically a vacant mill building and grain silos. The mill building was constructed in 1918 and the silos were constructed in 1951. The site and structures are landmarks to the City and an integral part of the Community's history. The site is listed in the Tempe Historic Property Register and determined to be eligible for listing in the National Register of Historic Places by the National Park Service and the structures hold a high symbolic value among Tempe residents. The site is also a vital link between the historic Tempe Downtown and burgeoning Tempe Town Lake.

Additionally, Tempe Butte, to include the Hayden Flour Mill property, is a Traditional Cultural Property and a known archaeological site. The proposal focuses on aspects that do the following:

- Mixed-use project that rehabilitates and reuses the mill building and silos in a manner that conforms to the Secretary of the Interior's Standards for Rehabilitation.
- Preserve the Butte as a habitat for desert vegetation, wildlife and natural resources, including such features as natural washes, native vegetation, rock outcroppings, and archaeological and paleontological features in a manner sensitive to the Butte's current listing in the National Register of Historic Places while providing appropriate public access, including established trailheads.
- Develop below the existing disturbed portion of the Butte, roughly the 1,180 feet above mean sea level (AMSL) line with potential areas of undisturbed portions of the Butte along the rail cut and former quarry area.
- Incorporate significant archaeological features integrating both arts and cultural elements that tell the story of the property's rich history, represent the full diversity of Tempe's founding citizens, and respect the Butte's significance to the Oodham, Piipaash, and their Ancestors.
- Provide a creative and entrepreneurial use for the historic mill to house office space tenants that continue Downtown's diversification into a hub of creative knowledge works
- Provide plazas and courtyards to host events and hospitality opportunities for food and beverage.
- Provide rooftop activation concepts, taking advantage of direct views of Downtown Tempe, Mill Avenue bridge, and Tempe Town Lake.
- Sustainability elements to promote shade and energy efficiency.
- Open space and connectivity to promote walkability and integration with the other commercial areas in the plaza as well as a pedestrian connection to the Butte trail system.
- Design and development that promotes diversity, local identity, and opportunities for events and art.

Both Venue Projects and Sunbelt Holdings are locally based and communicated considerable knowledge and appreciation for the historic value of this site. They are looking to share with the commission their respective expertise and redevelopment

concepts in the development of this project. Their proposal incorporates a great deal of community involvement to preserve the view corridors, the history and cultural significance of the site for generations to come and are requesting input from the commission regarding community vision for the site.
