2) Tempe Tomorrow: General Plan 2050

The Committee to select two members to represent the Joint Review Committee on the Technical Advisory Group

Suparna Dasgupta, Principal Planner, advised the Committee of the role the selected members would perform on the Technical Advisory Group, and the anticipated time commitment involved.

The greatest input for the General Plan 2050 will come from the public, so there are two main advisory groups that are going to participate on a monthly meeting basis. These meetings will be held in the evenings and be about one and half hours in length. They will be in person, and there is also virtual option available.

There is a citizen advisory committee as well as the technical advisory committee. The Technical Advisory Group will mostly consist of the boards and commissions that are involved in the City's development process, to provide technical advice on what the residents would like to see. The City is hoping to have two members from each board and commission, so at least one member can participate and rotate with the other member as an alternate, if needed. The idea is for those two members to then bring the items/discussions back to the other members of the committee to provide updates and get feedback to take back to the larger group. MAG, Maricopa County, and ASU will also be involved in the Technical Advisory Group. Ambika Adhikari, Principal Planner, and Shauna Warner, Neighborhood Services Director, will be taking the lead on this process.

Chair Robb advised that he had discussed this with Vice Chair Lufkin, and they are proposing that they both serve as the representatives. There was no objection from the rest of the Committee on this proposal. Ms. Dasgupta advised that other members can participate also, since there will also be public meetings.
